SMC Global Power Holdings Corp. (the "Corporation") hereby reports that during the Regular Meeting of the Board of Directors of the Corporation held on 07 May 2018, the Board approved the following matters:

a. the financial performance and financial position of the Corporation as of March 31, 2018, the details of which will be reported to the Securities and Exchange Commission ("SEC") and the Philippine Dealing & Exchange Corp. under SEC Form 17-Q due to filed on 15 May 2018;

b. the capital security distribution to holders of the USD300 Million Undated Subordinated Capital Securities which the Corporation issued on 26 August 2015, amounting to USD10,125,000 plus applicable taxes, payable on 26 August 2018;

c. the distribution to the holders of the USD650 Million Redeemable Perpetual Securities which the Corporation issued on 15 March 2018, amounting to USD10,156,250, payable on 16 June 2018; and

d. the relevant dates and details of the 2018 Annual Stockholders Meeting of the Corporation, to wit:

- (e) under the category Evaluation of Management's Process to Assess and Manage the Corporation's Enterprise Risk Issues, comprised of 6 questions, the average rating given by the members of the Audit Committee is 4.6.
- (ii) Board Directors Self-Rating Results
 - (a) under the category Fulfillment of the Board's Key Responsibilities, comprised of 9 questions, the average rating given by the members of the Board is 4.8;
 - (b) under the category Board-Management Relationship, comprised of 4 guestions, the average rating given by the members of the Board is 5;
 - (c) under the category Effectiveness of Board Processes and Meetings, comprised of 9 questions, the average rating given by the members of the Board is 4.9; and
 - (d) under the category Individual Performance of Board Members, comprised of 9 questions, the average rating given by the members of the Board is 5.
