SMC Global Power Holdings Corp. (the "Corporation") hereby reports that during the Special Meeting of the Board of Directors of the Corporation held on March 30, 2017, the Board unanimously approved, among others, the following matters:

- Acceptance of the resignation of Mr. Alexander B.M. Simon as Chief Finance Officer of the Corporation and as Deputy Corporate Information Officer of the Corporation for disclosures of the Corporation with the Philippine Dealing & Exchange Corp., effective March 30, 2017; and
- 2. Appointment of Mr. Paul D. Causon as the new Chief Finance Officer of the Corporation and the new Deputy Corporate Information Officer of the Corporation for disclosures with the Philippine Dealing & Exchange Corp., effective March 30, 2017.

Mr. Causon is likewise currently the Chief Finance Officer and Treasurer of Angat Hydropower Corporation (since 2014). He previously served as Vice President, Head of Treasury and Head of Special Projects of Philippine Airlines Inc. and Air Philippines Corporation (2013 – 2014); Chief Finance Officer & Treasurer of Liberty Telecoms Holdings, Inc. and Wi-Tribe Telecoms Inc. (2010 – 2013); Partner, Audit Banks and Other Financial Services Institutions of Manabat Sanagustin & Co., CPAs (2008 – 2010); and Vice President and Comptroller of China Banking Corporation (2006 – 2008). Mr. Causon is a Certified Public Accountant.
