SMC Global Power Holdings Corp. (the "Corporation") hereby reports that during the Regular Meeting of the Board of Directors of the Corporation held on August 11, 2016, the Board unanimously approved the following matters:

- a. approval of the financial performance and financial position of the Corporation as of June 30, 2016, the details of which shall be reported to the Securities and Exchange Commission and the Philippine Dealing & Exchange Corp. under SEC Form 17-Q due to be filed on August 15, 2016;
- b. declaration of cash dividends to shareholders owning common shares as of August 11, 2016, amounting to Php1,500,000,000.00, or approximately Php1.20 per common share, payable on August 18, 2016;
- c. capital security distribution to holders of the USD300 Million Undated Subordinated Capital Securities which the Corporation issued on May 7, 2014, amounting to USD11,250,000, plus applicable taxes, payable on November 7, 2016; and
- d. approval for the Corporation to enter into such relevant agreements and perform such obligations in its capacity as shareholder of San Miguel Consolidated Power Corporation ("SMCPC"), a wholly-owned subsidiary of the Corporation, in relation with the financing to be entered into by SMCPC for the completion of its 300MW Malita Power Plant.
