SMC Global Power Holdings Corp. (the "Corporation") hereby reports that on September 15, 2016, during the Special Meeting of the Board of Directors of the Corporation and at the Special Meetings of the Board of Directors and stockholders of SMC PowerGen Inc. ("SMC PowerGen"), a wholly-owned subsidiary of the Corporation, SMC PowerGen was authorized to negotiate, enter into and conclude with Petron Corporation the relevant definitive agreements for the sale by SMC PowerGen of its 140 MW Solid Fuel-Fired Power Plant located at the Petron Bataan Refinery (the "Power Plant") in favor of Petron Corporation, under such terms and conditions as Management may deem proper.

The Corporation shall make the appropriate disclosures to the Commission in the event the definitive agreements relating to the contemplated sale of the Power Plant is concluded with Petron Corporation.
