Gentlemen:

We reply with respect to the news articles posted in various online sites on June 26, 2023. In the attached news article entitled "ERC asks SC to void decision halting power deal" posted in BusinessWorld (Online Edition), it was reported in part that:

"The Energy Regulatory Commission (ERC) has asked the High Court to void the decision of the appellate court that suspended a power supply deal at a price lower than prevailing rates.

The ERC, through the Office of the Solicitor General (OSG), said that it filed before the Supreme Court (SC) on Friday a petition for certiorari to 'annul' the resolutions issued by the 13 Division of the Court of Appeals (CA) on April 3 and Jan. 25.

'It may be premature to say at this point how the SC will rule on the case. If the injunction is lifted or nullified by SC, then the PSA (power supply agreement) will no longer be suspended and the parties should resume performing their obligations,' ERC Chairperson and Chief Executive Officer Monalisa C. Dimalanta said in a Viber message to BusinessWorld on Sunday.

Meanwhile, in its January decision, the CA granted the writ of preliminary injunction sought by SPPC on its PSA with Meralco, thereby suspending its contract with the power distributor.

. . . .

By way of response to the Exchange, we advise that South Premier Power Corp. nor San Miguel Energy Corp. have yet to receive a copy of a petition for certiorari said to have been filed by the Energy Regulatory Commission with the Supreme Court to "annul" the resolutions dated January 25 and April 3, 2023 issued by the 13<sup>th</sup> Division of the Court of Appeals.
